- 4. Reporting Person elected to defer \$10,000 of retainer and meeting fees for the second quarter 2007 in exchange for share units. The number of share units was determined by dividing \$10,000 by \$40.43, the average of the high and low sale prices of a share of the Company's common stock on June 29, 2007.
