United Reports January 2014 Operational Performance

CHICAGO, Feb. 10, 2014 – United Airlines (UAL) today reported January 2014 operational results.

UAL's January 2014 consolidated traffic (revenue passenger miles) decreased 1.6 percent and consolidated capacity (available seat miles) decreased 2.8 percent versus January 2013. UAL's January 2014 consolidated load factor increased 1.0 point compared to January 2013.

About United

United Airlines and United Express operate an average of more than 5,300 flights a day to more than 360 airports across six continents. In 2013, United and United Express carried more passenger traffic than any other airline in the world and operated nearly two million flights carrying 139 million customers. In 2013, United became the first U.S. global carrier to offer satellite-based Wi-Fi, including on long-haul overseas routes.
