#### United Reports August 2015 Operational Performance

CHICAGO, Sept. 9, 2015 – United Airlines (UAL) today reported August 2015 operational results.

UAL's August 2015 consolidated traffic (revenue passenger miles) increased 1.5 percent and consolidated capacity (available seat miles) increased 2.3 percent versus August 2014. UAL's August 2015 consolidated load factor decreased 0.7 points compared to August 2014.

#### **About United**

United Airlines and United Express operate an average of nearly 5,000 flights a day to 362 airports across six continents. In 2014, United and United Express operated nearly two million flights carrying 138 million customers. United is proud to have the world's most comprehensive route network, including U.S. mainland hubs in Chicago, Denver, Houston, Los Angeles, New York/Newark, San Francisco and Washington, D.C. United operates nearly 700 mainline aircraft, and this year, the airline anticipates taking delivery of 34 new Boeing aircraft, including the 787-9 and the 737-900ER.
