- Each share unit represents the economic equivalent of one share of common stock. At time of distribution, Reporting Person will receive one share of common stock in exchange for each share unit, rounded up to the next whole share.
- Share units were received in connection with the special distribution by UAL Corporation of \$2.15 per share on January 23, 2008 to holders of UAL common stock on January 9, 2008. The number of share units received was equal to the dollar amount of the distribution that would have been payable if the share units held by Reporting Person on January 9, 2008 were actual shares of common stock, divided by \$33.98, the average of the high and low sale prices of a share of the Company's common stock on January 23, 2008.
- Delivery of shares of common stock in exchange for the share units will be made on the first business day in January following the calendar year in which Reporting Person ceases to be a director of the Company.
