Morgan and 4,024,300 shares through MS, each as its distribution agent, resulting in gross proceeds to the Company of \$124,493,694 and \$47,693,996,
respectively. The aggregate gross sales commission to the distribution agents through January 12, 2009 has been \$3,443,754. The aggregate net proceeds from
such sales are approximately \$168,217,420 after deducting related expenses, including commission to the distribution agents. The Company's common stock
is listed on The NASDAQ Global Select Market under the symbol "UAUA." The last reported sale price of the Company's common stock on January 12,
2009 was \$11.65 per share.
