- This transaction represents the withholding of shares to pay tax withholding obligations associated with the vesting of the restricted stock award granted on February 18, 2015. The award vests in 1/3 annual installments on February 28, 2016, 2017 and 2018.
- This transaction represents the withholding of shares to pay tax withholding obligations associated with the vesting of the restricted stock award granted on February 17, 2016. The award vests in 1/3 annual installments on February 28, 2017, 2018 and 2019.
- This transaction represents the withholding of shares to pay tax withholding obligations associated with the vesting of the restricted stock award granted on November 16, 2016. The award vests in 1/3 annual installments on February 28, 2017, 2018 and 2019.
- The RSUs were granted to the spouse of the reporting person on February 23, 2017 and vest in 1/3 annual installments on February 28, 2018, 2019 and 2020.
